

CONDITIONS

1. Entries must be the original work of the artist, not previously shown with this Society and completed within the past 12 months.
 2. Entries may include any sculpture, maquette or relief, free standing or on plinth, or a wall hanging. Entrants may submit up to two works. **All works must be for sale.**
 3. PLEASE NOTE: Acceptance of work is at the discretion of BDAS receiving committee dependent on size, weight and stability. Works intended for hanging must have appropriate hanging devices attached and suit BDAS' hanging system. The installation of larger works is the responsibility of the sculptor.
 4. A Label is to be attached by string to hang on the front of the work showing: NAME OF ARTIST, TITLE, MEDIUM & PRICE.
 5. Entry fee of \$25 (non-members) or \$15 for financial members of BDAS, must accompany each work, together with a completed entry form. Please make cheques payable to Bowral & District Art Society.
 6. A commission of 30% including GST, will be charged on all work sold during exhibitions.
 7. The Judge will view all entries and the Judge's decision is final. Due to gallery space restrictions the Judge will select appropriate number of works to be displayed for best viewing
- i. Entrants must arrange for delivery and collection of works at the specified times (see front of entry for details) **NO LATE ENTRIES WILL BE ACCEPTED.**

- ii. A penalty of \$10 will be imposed for late collection. Any work not collected within 30 days of closure of the exhibition will be disposed of at the discretion of the Committee.
- iii. The Committee reserves the right to have entries reproduced in the press, any publications, on television or any electronic media.
- iv. BDAS will exercise every care with works submitted, but will not be responsible for the loss of, damage to, or breakage of any exhibits in it's custody or for the insurance of exhibits either in transit or on exhibition.
- v. **ENTRIES NOT COMPLYING WITH THESE CONDITIONS WILL BE INELIGIBLE**

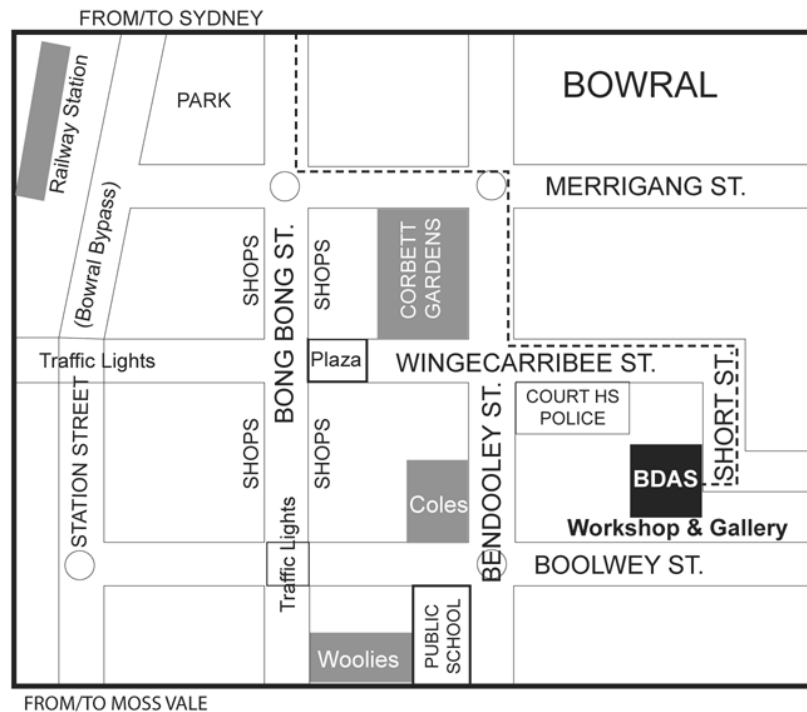
