

CONDITIONS OF ENTRY

STILL LIFE: A work of art depicting inanimate objects which may be natural or man-made. The work must be an original signed drawing or painting including mixed media or 3D work, or of a print making medium excluding photography, not previously shown with this Society, and completed in the past 12 months. Reproductions of work will not be accepted.

There is a limit of two works per artist. All works must be for sale.

The Judge and Curator will view all entries and their decision on work to be exhibited and prizes awarded will be final. There is no guarantee that all entries will be hung.

The artist warrants that they are the original author of the work. Furthermore, the work does not, to the best of the artist's knowledge, infringe the copyright or moral rights of any third party.

SUBMISSION OF ENTRY FORM & FEE

Exhibitors are required to complete the application form and submit this with the appropriate fee, to the BDAS office by 4pm on Wednesday 6 July, 2022

Members \$25 per work, Non-members \$35 per work

Payment of entry fees may be by cash, by credit card, by cheque, made payable to BDAS and posted to Bowral & District Art Society, PO Box 144, BOWRAL, NSW 2576. There is also a locked box outside the office for entries.

For payment via internet bank transfer, please ensure your name is noted on the internet transfer instructions and the date of payment is noted on the entry form.

SIZE & FRAMING

- Works must not exceed **1.25 m Width x 1.8 m Height** on outside measurement of frame, and are subject to a maximum weight restriction of 15kg
- All 2D works must either be framed or on a stretched gallery canvas.
- Works must be suitably prepared for hanging, with 2 D-rings 10-20cm from top of work.
- A label showing: Name of Artist, Title, Medium & Price is to be attached to the back of the work **and duplicated on a label attached by string to hang down below the art work** (for cataloguing purposes).

SALES & COMMISSION

A commission of 30% will be charged on all work sold. At the completion of the exhibition, the artist will be remitted the balance of the sale, less a further 1.5% EFTPOS surcharge (*where applicable) within 14 days by bank transfer. Please provide your bank details below.
