## CONDITIONS OF ENTRY - PLEASE READ CAREFULLY.

**STILL LIFE:** A work of art depicting inanimate objects which may be natural or man-made. The work must be an original signed drawing or painting, mixed media, printmaking or 3D work, but exclude photography, or digital reproduction. Must not have been previously shown in any BDAS prize exhibition, and must have been completed in the past 12 months. Artists may submit two works. All works must be for sale.

The Judge and Curator will view all entries and their decision on work to be exhibited and prizes awarded will be final. The BDAS do not pre-judge works by digital image. There is no guarantee that all entries will be hung. The artist warrants that they are the original author of the work. Furthermore, the work does not, to the best of the artist's knowledge, infringe the copyright or moral rights of any third party. Please acknowledge if AI imagery has been used.

***Bowral Art Gallery reserves the right to reject any work which does not comply with all conditions.***

### I HAVE READ AND AGREE TO ABIDE BY ALL THE CONDITIONS:

- Works must not exceed 1.25m WIDTH on outside measurement of the frame, and are subject to a maximum weight restriction of 12kg
- All works must be either framed, on a board or a stretched gallery canvas.
- A label showing: Name of Artist, Title, & Price is attached to the back of the work and duplicated on a label attached by string to hang down below the art work for cataloguing purposes.
- The work is ready for hanging with 2 D-rings 10-15cm from top of work, **free of wire or cords.**
- My details are correct
- I have filled out the tax declaration.
- I have read and accept the Copyright conditions.
- AI generated images have/have not been used in this work.

### SUBMISSION OF ENTRY FORM & FEE

Exhibitors are required to complete the application form and submit this with the appropriate fee, to the BDAS office by **4pm on 1 July, 2026**. Entry forms can be emailed or completed on-line. Entry fees are non-refundable.

- o Artists selected to be exhibited grant to the BDAS a non-exclusive, perpetual, royalty-free copyright licence to reproduce images of their work for the non-commercial purposes of the promotion of the BDAS, of future BDAS exhibitions and art prizes and for the BDAS on-line catalogue and social media platforms.
- o No alterations will be made to the image without the artist's consent.
- o The Artist will receive credit and be identified as the owner of the work.

### SALES & COMMISSION

- o A commission of 30% will be charged on all work sold.
- o At the completion of the exhibition, the artist will be remitted the balance of the sale, less a further 1.75% EFTPOS surcharge (\*where applicable) within 14 days by bank transfer.
