The work must be original and may include mixed media, printmaking or photography and 3D work, but exclude reproductions. The work must not have been previously shown in any BDAS prize exhibition. The artist may submit one work.

The artist warrants that they are the original author of the work. Furthermore, the work does not, to the best of the artist's knowledge, infringe the copyright or moral rights of any third party. Please acknowledge if AI imagery has been used.

SUBMISSION OF ENTRY FORM & FEE

Exhibitors are required to complete the application form and submit this with the fee to the BDAS office by 4pm on Wednesday 8 January 2025. Entry forms can be emailed. Entry fees are non-refundable.

Members \$25 per work

Payment of entry fees may be by cash, by credit card, by cheque or online made payable to BDAS and posted or emailed to Bowral & District Art Society, PO Box 144, BOWRAL, NSW 2576.

There is also a locked box outside the office for entries.

For payment via bank transfer, please ensure your name is noted on the transfer instructions and the date of payment is noted on the entry form.

PREPARATION OF WORKS

Note: Bowral Art Gallery reserves the right to reject any work which does not comply with all conditions.

- There is no size restriction but works are subject to a maximum weight restriction of 12kg
- All works must either be framed, on a board or a stretched gallery canvas.
- Works must be suitably prepared for hanging, with 2 D-rings 10-15cm from top of work.
- D-rings must be free of wire or cords. If necessary, a 2nd set of D-rings should be attached to the work.
- A label showing: Name of Artist, Title, & Price is to be attached to the back of the work.
- A second label with the same details, is to be attached by string to hang just below the lower edge the art work (this information is used when finalizing the catalogue).
- Please make sure your details are correct on all labels.
- Refer to the BDAS Website Entry Form page for more information.

COPYRIGHT

- The copyright remains the property of the entrant.
- Artists selected to be exhibited grant to the BDAS a non-exclusive, perpetual, royalty-free copyright licence to reproduce images of their work for the non-commercial purposes of the promotion of the BDAS, of future BDAS exhibitions and art prizes and for the BDAS on-line catalogue and social media platforms.
- No alterations will be made to the image without the artist's consent.
- The Artist will receive credit and be identified as the owner of the work.
- The Artist might like to be transparent and disclose if AI generated images have been used to help create their work.

SALES & COMMISSION

- A commission of 25% will be charged on all work sold. At the completion of the exhibition, the artist will be remitted the balance of the sale, less 1.75% EFTPOS surcharge (*where applicable) within 14 days by bank transfer.

DELIVERY & COLLECTION

- Entrants must arrange for delivery and collection of works at the specified times (see front of entry for details) or by prior delivery to the BDAS Office
1 Short St Bowral during Office Hours.
- Any work not collected within 30 days of closure of the exhibition may be disposed of at the discretion of the Committee.

INSURANCE

BDAS will exercise every care with works submitted, but will not be responsible for the loss of, damage to, or breakage or damage caused by any exhibits in its' custody or for the insurance of exhibits either in transit or on exhibition. Exhibitors may wish to arrange their own insurance.
